## **Unofficial Minutes**

CORINNA TOWNSHIP BOARD MEETING Tuesday, October 4, 2011, 7 p.m. Corinna Township Hall 9801 Ireland Avenue NW, Annandale, MN

Present: Chairman John Dearing; Vice-Chairman Richard Naaktgeboren; Supervisor Chuck Carlson; Clerk/Treasurer Mary Barkley Brown; Deputy Clerk/Treasurer Jennifer Kemp

Others in Attendance: Local 49 Union Rep Kent Courrier; Maintenance Men Mark Miller and Doug Smith

<u>6:30 p.m.</u> <u>International Union of Operating Engineers</u>: IUOE Representative, Kent Courrier, and Corinna Township Maintenance Men contract negotiation for 2012 was held in response to IUOE letter to Corinna stating "Desire to Negotiate", sent by Kent Courrier on 6/24/2011.

Dearing called the Special Negotiations Meeting to order at 6:42 p.m.

Both sides agreed that the new Maintenance Outlook Report has been going well.

A discussion was held regarding wages and benefits for 2012. There had been a 0% wage increase for 1/1/2011 – 12/31/2011, along with an increase of \$17 per month in health insurance that the township paid on behalf of maintenance men.

After discussion, a motion was made by Naaktgeboren, seconded by Carlson, to approve a 0% wage increase for 1/1/2012 - 12/31/2012, along with the township paying both the \$20 per month health insurance premium increase in 2012 and the \$50 per month portion of the health insurance premium that the maintenance men had been paying on their own behalf each month. Motion carried unanimously.

Courrier asked if contract could be for three years, rather than 2 as in the past. After discussion, a motion was made by Naaktgeboren, seconded by Carlson, to approve a contract for three years. Wages and benefits for years 2013 and 2014 will be determined in the preceding year, after the health insurance premium has been determined by the IUOE.

Courrier will attend the 11/1/2011 Town Board Meeting for the purpose of signing the IUOE Local 49 contract.

Regular Meeting Call to Order and Pledge of Allegiance was at 7:00 p.m.

<u>September 20, 2011 Town Board Meeting Minutes</u>: A motion was made by Naaktgeboren, seconded by Dearing, to approve the September 20, 2011 Town Board Meeting Minutes. Motion carried unanimously.

Agenda for the October 4, 2011 Town Board Meeting: A motion was made by Naaktgeboren, seconded by Carlson, to approve the Agenda for the October 4, 2011 Town Board Meeting, with the following addition: New Business #8 – Propane and Diesel Quotes. Motion carried unanimously.

Maintenance Men: Work order log; reviewed work orders # 48, 51, 81; 86; 101; 103; Gravel/culvert on Lathrop/Kramer AV is scheduled to be installed 10/5/2011 – Miller has met with Marc Mattice; Check for \$360 for tank sale from Lampi Auction of 9/17/2011 was received; Cemetery sprinkler heads and rust-proof treatment will be looked at next Spring by Carlson; Irvine Avenue survey posts were discussed – It will be very difficult to plow the road due to the large stakes; Tree trimming planned in the Fall; Grass seed matting & driveway run-off at 8448 96<sup>th</sup> ST NW were reviewed – Smith repaired damage to the township road from driveway run-off as best he could. <u>Crack Seal, Seal Coating, Dust Coating and Road Striping</u>: Town Hall parking lot was striped 10/4/2011. Hemlock striping correction was addressed with City of Annandale and Traffic Marking Services and will be corrected ASAP.
