CORINNA TOWNSHIP AND WRIGHT COUNTY REACH ONE-YEAR AGREEMENT ON ZONING AND BUILDING CODE ADMINISTRATION

Residents Will Only Need to go to Township for Permits and Hearings

On December 28, 2010, the Wright County Board of Commissioners and the Corinna Township Board of Supervisors reached an agreement regarding the administration of septic system permitting and zoning ordinances in the shoreland areas of Corinna Township; this agreement will be in effect through the end of 2011, at which time it will be re-assessed.

The agreement specifies that:

- Corinna Township will administer all land use (zoning), floodplain, building and septic
 permitting, with building and septic system permit review and inspections being conducted by
 Wright County staff;
- Corinna's zoning staff will conduct land use permit reviews and inspections related to the Zoning Ordinance:
- Applicants will drop off all applications and pick up and pay for all permits at Corinna Town Hall

With the exception of rezoning of properties, all land use public hearings (variances, conditional use permits, preliminary plats, etc.) will be handled completely by Corinna Township and there will be no need for applicants to obtain final approval of such applications from Wright County.

The agreement is the result of more than four months of negotiations between County and Township officials. The Corinna Township Board would especially like to thank Wright County Commissioner Rose Thelen for her tireless efforts to bring this agreement to reality.

- 3. Presentation of proposed 2012 budget. (Only in township government do the citizens who attend the Annual Meeting approve or amend the budget.)

MAILBOX REMINDER

Please make sure your mailbox post is in good condition. Check to see that it is firmly in the ground. Pressure from plowed snow can knock over a rotted mailbox post. Mailboxes should be set 42" to 44" above the ground. Mailboxes will only be repaired or replaced if the mailbox support was damaged by a direct hit from township equipment. Mailbox supports (swing-away type) are available for purchase from the Wright County Department of Highways.

New Guidelines for Recycling:

Cans, mixed glass and plastic may be combined.

<u>Cans</u>: Aluminum and tin cans, including the lids. All cans must be rinsed and labels on tin cans removed.

<u>Glass</u>: All glass food and beverage containers. All glass containers must be rinsed and lids or covers should be removed. Labels may be left on glass jars.

<u>Unacceptable glass items</u>: Broken glass, light bulbs, windows, dished, drinking glasses and lids. <u>Plastic</u>: All plastic bottles with necks accepted. All plastic containers must be rinsed thoroughly and caps removed. Labels may be left on.

<u>Unacceptable plastic items</u>: Yogurt, pudding and fruit cups, produce or deli take out containers, toys and automotive fluid containers.

<u>Paper</u>: All newspapers (including the inserts), magazines, phone books, and any junk mail. Make certain it is kept clean and dry. All paper must be separated from other recyclables and placed in paper bags.

<u>Cardboard</u>: All cardboard must be broken down flat and bundled. This includes cereal boxes, flattened and plastic bag removed. Please place in a paper bag or bundle. Maximum length and width should not exceed 3 feet.

PARKING IS NOT ALLOWED ON TOWNSHIP ROADS

Grading and plowing equipment need to maintain the entire road surface. Also please note that it is illegal to push snow across public roads.

DOGS

Corinna Township has obtained the services of Sue Eaton as the Animal Control officer. Most of her activities deal with lost or stray animals. If you have a problem with a stray animal contact Animal Control Officer Sue Eaton at 612-366-4370. Impounded animals are taken to the Annandale Veterinary Clinic – phone 320-274-3535.

DANGEROUS AND POTENTIALLY DANGEROUS DOGS

On Jan. 19, 2010 Wright County adopted an Ordinance for Dangerous and Potentially Dangerous Dogs. This Ordinance will allow the County to regulate the ownership and possession of dangerous dogs and potentially dangerous dogs. The purpose of the Ordinance is to protect the public from such dogs and to reduce the threat to the health and safety of people and other animals that may come into contact with such dogs. A copy of the Ordinance is available at the Corinna Town Hall.

EMERALD ASH BORER / CORINNA TOWNSHIP BRUSH PILE

The Minnesota Department of Agriculture has notified Corinna Township that we may **NOT** allow dumping of ash tree material in our brush pile at the township hall. This is to help slow the spread of Emerald Ash Borer. Thank you for your cooperation!

BURNING PERMITS AND FIRE WARDEN CONTACTS

Burning Permits: Burning permits are required for open burning unless there is three inches of snow cover.

Burning the following items is strictly prohibited:



- -Hazardous wastes, industrial solid waste
- -Demolition debris of commercial or institutional structures. (A farm building is not a commercial structure.) Burning of any structure should be referred to a forest officer.
- -Salvage operations
- -Motor vehicles
- -Oils
- -Rubber
- -Plastics
- -Chemically-treated materials
- -Other materials which produce excessive or noxious smoke, such as, but not limited to: tires, railroad ties, chemically-treated lumber, composite board, sheet rock, wiring, paint, or paint filters
- -Garbage, defined as discarded material resulting from the handling, processing, storage, preparation, serving, or consumption of food
- -It is **never** permissible to burn household garbage.
