<u>Maintenance Outlook Report</u>: Reviewed. A discussion was held regarding gravel needed on Lathrop AV NW, from County Road 39 to the "Y" intersection, in the Clearwater/Pleasant Regional Park. Hauling and spreading the gravel had been OK'd by Marc Mattice a few days earlier. A discussion was held. A motion was made by Dearing, seconded by Carlson, to haul and spread gravel, on Lathrop AV NW, from County Road 39 to the "Y" intersection, in the Clearwater/Pleasant Regional Park. Motion carried unanimously.

- <u>Planning Commission</u>: Charlotte Quiggle, Chairman, was not in attendance.

 <u>Next Corinna Planning Commission Meeting</u>: Wednesday, 8/15/2012 (due to election primary on 8/14/2012).
- 2. 8408 County Road 7 NW Noxious Weed Violation: Weeds have been cut.
 8448 96th Street NW Junk Violation: Junk violation letter sent 4/18/2012. Letter states that the owner has 30 days to clean up the property, or until 5/18/2012; Corinna letter of 5/29/2012 to Sheriff Joe Hagerty; 6/8/2012 Sheriff's Deputy visited site. After speaking to Naaktgeboren, homeowner was given one additional week to finish cleaning up property in order to avoid a citation; 6/19/2012 Officer Olson reinspected and noted that some progress has been made. Homeowner given until 7/9/2012 meeting to finish clean-up; Dearing will check at later date for further progress.
- 3. <u>Corinna Road Sign Inventory</u>: No action taken.
- 4. Road Work at 108th ST NW and Knowles AV NW: Dennis Taylor, from Taylor Land Surveyors, Inc., addressed the town board. He presented copies of a site plan for road realignment, making a "T", and therefore a safer intersection at Knowles and 108th. 108th is being moved to accommodate Camp Friendship's existing building, in exchange for Right-of-Way from Camp Friendship in the new intersection of Knowles and 108th. The town board asked Taylor to stake the corner of 108th and Knowles ASAP and to prepare the legal documents necessary for this project. Taylor said he would stake out the road the week of 8/13/2012.
- 5. <u>Primary Election Tuesday, August 14</u>: Hourly rate of pay for election judges was discussed. Election judges' responsibility has become greater with each election due to changes in state statutes, and the

- election rules are becoming increasingly complicated. A motion was made by Carlson, seconded by Dearing, to increase the rate of pay to \$15 per hour. Motion carried unanimously.
- 6. <u>AED</u>: Tabled until next meeting.
- 7. <u>Junk Amnesty</u>: Did not review, as all invoices have not been submitted to the township yet.
