CORINNA TOWNSHIP BOARD MEETING Tuesday, November 19, 2013, 7:00 p.m. Corinna Township Hall 9801 Ireland Avenue NW, Annandale, MN

Meeting Call to Order and Pledge of Allegiance was at 7:00 p.m.

Present: Chairman Chuck Carlson; Vice-Chair John Dearing; Supervisor Richard Naaktgeboren; Clerk/Treasurer Mary Barkley Brown.

Absent: Deputy Clerk/Treasurer Jean Just.

Others in Attendance: Corinna Planning and Zoning Administrator Ben Oleson; Tena Rytel; Paul Downer; Wayne Bauernschmitt.

Approve or Amend Agenda, Town Board Meeting, November 19, 2013:

A motion was made by Naaktgeboren, seconded by Dearing, to approve the Agenda with the following addition: Joyce Martin Thank You Note of 11/16/13 to Corinna Township Board. Motion carried unanimously.

Approve or Amend Minutes, Town Board Meeting, November 5, 2013:

A motion was made by Dearing, seconded by Naaktgeboren, to approve the Minutes of the Town Board Meeting of November 5, 2013. Motion carried unanimously.

Notice of Hearing on Proposed Fire Assessment: Carlson opened the public hearing to consider special assessments for fire protection from the Annandale and Maple Lake Fire Departments. The special assessment per parcel in the Annandale Fire District is \$68 per parcel for the year 2014, and \$55 per parcel for properties in the Maple Lake Fire District. The hearing was opened for public comment. There were no public comments. Carlson entertained a motion to adopt Resolution #2013-05, the resolution adopting special assessments for fire protection. A motion was made by Naaktgeboren, seconded by Dearing to adopt Resolution #2013-05, with the special assessments for fire protection at the rate of \$68 per parcel for the year 2014 in the Annandale Fire District, and \$55 per parcel for properties in the Maple Lake Fire District. Motion carried unanimously.

<u>Local 49 Rep Kent Courrier</u>: Reviewed proposal sent by Courrier. Courrier was not in attendance. Town Board would like to meet with Courrier and Corinna Maintenance Department on 12/3/13 at 6:15 p.m., before the Regular Town Board Meeting.

<u>108<sup>th</sup> Street Project</u>: Naaktgeboren reported that the seeding is done. <u>Joyce Martin Thank You Note of 11/16/13 to Corinna Township Board</u>: Reviewed.

<u>Township Signing Project</u>: Sign installation began 8/23/13; Majority of work completed 9/6/13. 80<sup>th</sup> Street NW and some miscellaneous street signs still need to be completed.

Maintenance Outlook Report: Reviewed.

<u>Post Driver Information</u>: Reviewed a second quote. No action taken.

## Requests to be on the Agenda:

1. Tena Rytel, from Geronimo Energy, addressed the Town Board regarding Xcel Energy's Petition to Seek Approval for a Competitive Resource Acquisition Proposal, PUC Docket Number E-002/CN-12-1240 OAH Docket Number 8-2500-30760. The representative outlined Geronimo Energy's proposal to install a solar panel site in Corinna Township, near the City of Annandale. Rytel said that this would be for a 2.5 megawatt project. There would be several 4' x 6' panels. The project would take up 30 acres. It is noiseless. The panels are fairly low to the ground and could easily be hidden by trees. There will be a fence around the project. Ben Oleson stated that he would have to discuss more with Wright County Planning and Zoning to determine if such a project would use up a building entitlement. A motion was made by Naaktgeboren, seconded by Dearing, to approve

support for consideration of alternate energy solutions and actions that provide economic benefit to Corinna Township, if these actions do not pose a negative impact to the public, with a reservation regarding the decommissioning or clean-up of this project at the end of its life, with either an escrow or a bond for decommissioning. Motion carried unanimously. The Town Board also supports the public input process that Geronimo Energy has outlined. Rytel said that if the project is approved, Geronimo Energy will work with the township to meet ordinance requirements. Clerk Brown was instructed to send a letter of support to The Honorable Eric L. Lipman at the MN Office of Administrative Hearings. Rytel was asked to send the Township information regarding decommissioning or clean-up of this project at the end of its life, with either an escrow or a bond for decommissioning.

<u>Planning and Zoning Administrator's Report</u>: Oleson reported that at the Wright County Commissioners Meeting of 11/19/13, they voted to have their Attorney's Office draft a resolution that would recognize Corinna as the shoreland zoning authority – to be voted on formally on December 3<sup>rd,</sup> 2013. It was a 3-2 vote (Sawatzke and Husom against).

Request for Determination: 11/7/13 Corinna Request to Wright County P and Z and to Wright County Attorney Kryzer for determination that Corinna Township has met the criteria for shoreland zoning administration was reviewed.

Wright County Board Committee of the Whole Meeting Minutes of 11/6/13: Reviewed.

<u>PID # 206-000-032200</u>: Report of people living in home that was to be removed and disposed; 9/3/13 Ben Oleson letter to property owner asking owner to contact Oleson within 5 days. Property owner's response to Oleson on approximately 9/20/13 was that he wished to keep using the dwelling for 2-5 more years. Oleson letter of 11/8/13 sent to the landowner, Sean Riley and Greg Kryzer. Oleson said he received a phone call from property owner.

PID #206-061-000010, 7496 Isaak Avenue NW Violation Letter: Oleson letter of 9/16/13 to Stone regarding shed in road right-of-way. Property owner was given 5 business days to contact Oleson. Stone contacted Oleson and said he is applying for a permit to move the shed to a different location on the property. Oleson said Stone indicated they would likely need a variance. Stone submitted an incomplete application as they are verifying the location of property lines. Oleson will contact Stone again.

PID #206-000-272401, 7622 Isaak Avenue NW Violation Letter: Oleson letter of 9/16/13 to Rood in regard to land alteration work done on property. Property owner was given 5 business days to contact Oleson. Oleson inspected the property on 10/1/13 and took photos of tree stumps. Most showed signs of rot inside the trunks. Silt fence was in place. Oleson contacted Wright Soil and Water. They said the project could remain as is over the winter with the silt fence remaining in place. Oleson letter of 10/29/13 to Rood was reviewed. Oleson said the underground irrigation has been installed, but sod has not been installed yet. Oleson will follow up with Rood.

<u>PID # 206016000010:</u> Kobe's addition of a deck, screen porch and more, done without a permit. Oleson spoke to Kobe, who said he is working with Surveyor Bogart Peterson and with a sewer contractor. <u>8987 Iresfeld AV NW - PID # 206-000-153404</u>: Building permit was issued in 2005 by Wright County and that it is still open and there is also a non-conforming sewer. Oleson will follow up, checking on sewer and also on time allowed to complete the building of the dwelling. Oleson was directed to send a letter to the landowner regarding any unfinished work on the home or sewer.
