CORINNA TOWNSHIP BOARD MEETING Tuesday, June 16, 2015, 7:00 p.m. Corinna Township Hall 9801 Ireland Avenue NW, Annandale, MN

Meeting Call to Order and Pledge of Allegiance was at 7:00 p.m.

Present: Chairman Richard Naaktgeboren; Vice Chairman Chuck Carlson; Supervisor John Dearing; Clerk/Treasurer Mary Barkley Brown.

Approve or Amend Agenda, Town Board Meeting, June 16, 2015: A motion was made by Carlson, seconded by Dearing, to approve the Agenda with the following additions: Ken Yager Assessor Contract; Jeff Lundquist Planning Commission Resignation; Corinna July Newsletter; LaPlant Demo Quote; Wright County Township Officers' Association Meeting of 7/8/2015; Wright County Township Officers' Association Minutes of 4/9/2015 Meeting; Wright County Snowplowing Emergencies Procedure Proposal and Memo of Understanding; Chris Ferrell Drain Field Request. Motion carried unanimously.

<u>Approve or Amend Minutes, Town Board Meeting, June 2, 2015</u>: A motion was made by Dearing, seconded by Naaktgeboren, to approve the Minutes of the Town Board Meeting of June 2, 2015. Motion carried unanimously.

Maintenance Outlook Report: Reviewed.

Quote for Tiling: At previous meeting of 6/2/2015 the Maintenance Men were directed to measure all proposed projects, send request to MN Pipe to quote all culvert pipe and parts needed for the following projects: 75th Street NW Somers Lake drain exit; 72<sup>nd/</sup> Imhoff (Ralph Wurm area); Jeske and 98<sup>th</sup>; Imhoff AV NW (by Bakken); and near 6370 102nd St NW (Gordon area). The Board felt MN Pipe has the best quality culvert and pipe products. A motion was made by Dearing, seconded by Carlson, to purchase all pipe and aprons quoted on 6/9/15, for a total of \$28,921.24. Motion carried unanimously.

## Requests to be on the Agenda:

<u>Ken Yager Assessor Contract</u>: Yager's contract with Corinna ends June 30, 2015. Yager's new proposed contract contained no price increase. The Town Board expressed to Yager that they have been very pleased with his service. A motion was made by Carlson, seconded by Dearing, to renew Assessor Ken Yager's contract with Corinna Township for the period July 1, 2015 – June 30, 2017. Motion carried unanimously.

<u>Jeff Lundquist Planning Commission Resignation</u>: A motion was made by Naaktgeboren, seconded by Carlson, to accept Lundquist's June 10, 2015 letter of resignation as alternate on the Corinna Planning Commission. Lundquist wrote that he did not have the time needed to properly do the job. Motion carried unanimously. Clerk Brown was directed to write a thank you note to Lundquist for the time spent on the Planning Commission.

A contractor is in the process of cleaning up property at this time.

Ben Oleson Letter of 5/11/15 to Owner of PID# 206-049-001250 at 6636 80<sup>th</sup> Street NW: Strzyzewski reported that he has cleaned the property, but Oleson has not yet inspected to verify. PID # 206-000-153404 - 8987 Iresfeld AV NW: Oleson reported that building is completed, however Oxenford's septic system is not complete. Oleson letter of 6/15/15 was reviewed. Letter states that the replacement of Oxenford's septic system must be completed by 9/30/15. Clerk Brown was advised to send letter by certified mail.

   Association Minutes of 4/9/2015 Meeting: Reviewed. Clerk Brown was advised to RSVP the upcoming meeting. All three supervisors plan to attend.
- 10. Wright County Snowplowing Emergencies Procedure Proposal and Memo of Understanding: Reviewed.
- 11. Chris Ferrell Drain Field Request: Ben Oleson's e-mail of 6/16/15 to Corinna Township stated that Chris Ferrell is designing a sewer drain field at 11167 Hoyer AV NW to go right up against the road right of way. It would be on a portion of the lot that is the second tier back from the lake and would be on the east side of the property. They need to put it there because there is a shallow well in the southwest corner of the house on a property that he has to be 100 feet away from. Troy Johnson from Wright County has already inspected the property and has no issues himself. The Town Board called and spoke to Ben Oleson during the meeting. A motion was made by Naaktgeboren, seconded by Carlson, to allow the drain field to go up against the road right of way, as long as it is a minimum of 10 feet back from the driving surface of the road. Motion carried unanimously.

<u>Any Other Business That May Come Before the Board</u>: E-mail of 6/15/15 from Community Green Energy, LLC regarding community solar garden proposal was reviewed. Town Board said they are not interested.
