CORINNA TOWNSHIP BOARD MEETING Tuesday, February 16, 2016, 7:00 p.m. Corinna Township Hall 9801 Ireland Avenue NW, Annandale, MN

Meeting Call to Order and Pledge of Allegiance was at 7:00 p.m.

Approve or Amend Agenda, Town Board Meeting, February 16, 2016: A motion was made by Dearing, seconded by Carlson, to approve the Agenda as presented with the following additions: Christine Husom request to be on the Agenda; Wright County Planning Commission Meeting Minutes of 1/14/16 Regarding Rachel Properties, LLC; Wright County Highway Department Highway Engineer Virgil Hawkins Letter of 2/11/16 Regarding Wright County's Five-Year Highway Improvement Plan Meeting of 2/23/16; Wright County P and Z Administrator Sean Riley Memo of 2/4/16 Regarding Solar Energy Ordinance 762 - Tentative Meeting Date of 3/22/16; Schlenner Wenner Manager Ryan Schmidt E-mail of 2/12/16, Including Legal Compliance Audit Guide - Conflicts of Interest. Motion carried unanimously.

<u>Approve or Amend Minutes, Town Board Meeting, February 2, 2016:</u> A motion was made by Dearing, seconded by Carlson, to approve the Minutes of the Town Board Meeting of February 2, 2016. Motion carried unanimously.

Open Bids for Loading and Hauling of Class 1 Gravel on Township Roads:

The hauling bids were as follows:

Mid MN Hot Mix

\$3.90/cubic yard, haul and spread, from APR pit;

ML Schendzielos and Son, Inc.

\$3.47/cubic yard, haul and spread, from APR pit;

Bjorklund Companies

\$3.54/cubic yard, haul and spread, from APR pit.

A motion was made by Dearing, seconded by Carlson, to award the gravel loading, hauling and spread, from ARP pit, to Bjorklund Companies, for \$3.54/cubic yard. Although ML Schendzielos and Son, Inc. had the lowest bid, the Town Board was not able to determine if their equipment was adequate/suitable for this job. The Town Board did not know what a quint truck was. Corinna does not use side dumps for this work. No one was in attendance to answer the questions. Motion carried unanimously.

Open Bids for Calcium Chloride or Magnesium Chloride Materials and Application:

The Town Board opened the four bids that were submitted. They were as follows:

Calcium Chloride Materials and Application:

Tri City Paving

\$0.98 per gallon for calcium chloride at 38%;

Northern Salt Inc.

\$0.939 per gallon for calcium chloride at 38%;

Magnesium Chloride Materials and Application:

Envirotech Services, Inc.

\$0.835 per gallon for magnesium chloride at 30%;

Central Minnesota Dust Control, LLC quoted two options:

\$0.89 per gallon for magnesium chloride at 30%;

\$0.915 per gallon for magnesium chloride at 33%. (Normal application rate of

.27) Magnesium chloride 33% is .5% stronger than 38% calcium chloride. It is less corrosive than calcium chloride and performs better during dry conditions.

A motion was made by Carlson, seconded by Dearing, to accept bid from Central Minnesota Dust Control, LLC, for Dustguard Plus Liquid Magnesium Chloride at 33%, at the price of \$0.915 per gallon, for approximately 100,000 gallons. Motion carried unanimously.
