CORINNA TOWNSHIP BOARD MEETING Tuesday, October 3, 2017, 7:00 p.m. Corinna Township Hall 9801 Ireland Avenue NW, Annandale, MN

Call to Order and Pledge of Allegiance was at 7:00 p.m.

Approve or Amend Agenda, Town Board Meeting, October 3, 2017: A motion was made by Smith, seconded by Dearing, to approve the Agenda with the following additions: Special Assessment for Fire Departments; Wright County Notice of Public Hearing Regarding Jane Goodall Environmental Sciences Academy. Motion carried unanimously. Copies of the previous Meeting Minutes and this Meeting's Agenda are available for those attending this meeting.

<u>Approve or Amend Minutes, Town Board Meeting, September 19, 2017</u>: A motion was made by Smith, seconded by Dearing, to approve the Minutes of the Regular Town Board Meeting of September 19, 2017. Motion carried unanimously.

Maintenance Outlook Report: Reviewed quotes for paving an approximately 60' x 160' x 6" thick bituminous pad under the brush pile. Quotes were as follows: Mid MN Hot Mix: \$27,960; Knife River \$22,470. A motion was made by Smith, seconded by Carlson, to approve the quote from Knife River, at \$21 per square yard. Area to be paved will be re-measured and may be larger. Motion carried unanimously.

<u>Gravel Quotes for 2018</u>: A motion was made by Carlson, seconded by Smith, to request quotes for 10,000 c/yards (more or less) of Class 5 gravel – loaded. Gravel pit must be within 10 miles of Corinna Town Hall. Quotes will be opened at October 17, 2017 Regular Town Board Meeting. Motion carried unanimously.

- 6. <u>Encroachment License</u>: Township Attorney Tim Young reviewed a draft Encroachment License to put a sewer pipe under road at 11702 Hollister AVE NW, to connect Mark and Monica Raskob's two parcels, PID# 206-000-021301 and PID# 206-011-000030. This draft Encroachment License was tentatively approved at 9/19/2017 Regular Town Board meeting, pending review and approval by Township Attorney Tim Young. Young found problems with this agreement, did not approve of it, and has been in contact with Raskob. There has been no further action taken by Raskob as of this meeting.
- 7. <u>Midco</u>: After researching the issue, Clerk Brown discussed the possibility of continuing phone service with Windstream, and switching internet to Midco. Town Board did not object to this.
- 8. <u>Cemetery Fence and Sign</u>: Work is scheduled to begin October 6, 2017.

- 9. <u>Special Assessment for Fire Departments</u>: A motion was made by Dearing, seconded by Smith, to hold a Public Hearing on Wed., Nov. 8, 2017 to consider Annandale Fire Department and Maple Lake Fire Department Special Assessments for 2018. Motion carried unanimously.
- 10. Wright County Notice of Public Hearing Regarding Jane Goodall Environmental Sciences Academy: Hearing will be Thursday, November 16, 2017 at 7:30 PM at the Wright County Government Center.
