Approve or Amend Agenda, Town Board Meeting, September 19, 2017: A motion was made by Carlson, seconded by Smith, to approve the Agenda with the following additions: Wright County Township Officers' Association Quarterly Meeting and Minutes; Encroachment License – Schabel/Raskob; Second Dog Notice Letter of 9/18/2017 PID#206-075-000010; Midco Proposal.
