## **Urgent Winter Bulletin**

*As you know, this is the coldest winter since 1996, and February might set a record for snow. In addition to freezing pipes and septic systems, making arrangements for kids when school closes, and keeping cars running, **we need your help with snow plowing.***

*Our crews try to plow our roads as quickly and as often as possible. You can help. Anything parked in the right-of-way - cars, trucks, snowmobiles, docks, boats, RV's - slows down the plows and is a hazard to our drivers and equipment.*

*Corinna Township has an ordinance explaining what is allowed and what is not. In extreme cases, a violator may have their property removed or towed and a ticket issued. The Town Board hopes everyone will voluntarily comply with the rules.*

***Please help us keep the roads open and safe for you, school buses, first responders, and our drivers.***

## **WINTER PARKING IN TRAVELED PORTION OF ROAD RIGHT-OF-WAY**

**No person shall park any vehicle, motorized or non-motorized, within any part of the traveled portion of a Road Right-of-Way during the hours of 12:00 midnight through 7:00 a.m. between November 1 and April 1.**

## **SNOWFALL PARKING IN TRAVELED PORTION OF ROAD RIGHT-OF-WAY**

**No person shall park any vehicle, motorized or non-motorized, within any part of the traveled portion of a Road Right-of-Way at any time during or after a snowfall until the entire traveled portion of the Right-of-Way is plowed to its customary width. Also - it is illegal to push snow across public roads. Snow must be placed on private property.**

## **ROAD RIGHT-OF-WAY**

**No person shall place, maintain, or allow any obstruction in a Right-of-Way.** Prohibited items include, but are not limited to, retaining walls, fences, posts, structures, piled materials, hay bales, vehicles, trailers, campers, boats, pontoons, docks, boat houses, fish houses, equipment, junk, or any other items that interfere with the safe use or maintenance of the Right-of-Way. No

one may plant crops, trees, bushes, or shrubs within a right-of-way. No one may place watering systems or sprinkler heads within a right-of-way.

## **MAILBOX REMINDER**

Please make sure your mailbox post is in good condition. Check to see that it is firmly in the ground. Pressure from plowed snow can knock over a rotted mailbox post. Mailboxes should be set 42" to 44" above the ground. Mailboxes will only be repaired or replaced if the mailbox support was damaged by a direct hit from township equipment and if the mailbox support meets the township's standards. Mailbox supports (swing-away type) are available for purchase from the township.

## **ANNUAL MEETING AND ELECTION, TUESDAY, MARCH 12, 2019**

One Township Supervisor will be elected for a three-year term. Larry Smith has filed for this position. Polls will be open from 10:00 AM to 8:00 PM at the Corinna Township Hall located at 9801 Ireland Avenue NW. The Annual Meeting will begin at 8:15 PM after the polls close. The agenda items for the Annual Meeting include:

1. Report from Township Board on completed projects for 2018, projects for 2019 and projects proposed for 2020.
2. Presentation of proposed 2020 budget.

## **ABSENTEE VOTING**

You may vote by absentee ballot by completing the absentee ballot application on website [www.sos.state.mn.us](http://www.sos.state.mn.us) and sending it to the Wright County Auditor Treasurer's Office-Elections; or by calling the Wright County Auditor Treasurer at 1-800-362-3667 to request an absentee ballot application; or you may vote in person at the Wright County Courthouse. Absentee voting begins Friday, February 8 and ends Monday, March 11 at 5 p.m.

## **BOARD OF APPEAL AND EQUALIZATION**

The Local Board of Appeal and Equalization Meeting will be held on Thursday, April 11, 2019 at 3:00 PM at the Corinna Township Hall. ## **BUILDING, SEWER, LAND USE and ZONING PERMITS**

You may drop off completed applications or plans in the drop box after hours. Please bring these permit applications to the Corinna Town Hall.

## **TOWNSHIP ROAD SUPPLIES**

Please do not remove black dirt, sand, gravel or salt from the Corinna Town Hall property. Violators will be prosecuted.

## **COMPOST, WOOD CHIPS AND FIREWOOD**

Township residents may take free compost, wood chips and firewood from the piles on the Corinna Town Hall property. Only township residents may deposit materials onto the piles. No commercial dumping is allowed.

## **EMERALD ASH BORER / CORINNA TOWNSHIP BRUSH PILE**

The Minnesota Department of Agriculture has notified Corinna Township that we may not allow dumping of ash tree material in our brush pile at the Corinna Township Hall. This is to help slow the spread of Emerald Ash Borer.

## **JUNK CLEAN-UP DAY**

Junk Clean-Up Day will be held Saturday, July 27, 2019, from 7:30 AM to noon, at the Corinna Township Hall. You will receive a newsletter in July giving you more details about Junk Clean-Up Day.

## **BURNING PERMITS AND FIRE WARDEN CONTACTS**

Burning Permits: Burning permits are required for open burning unless there are three inches of snow cover.

### **Burning the following items is prohibited:**



- Hazardous wastes, industrial solid waste
- Demolition debris of commercial or institutional structures. (A farm building is not a commercial structure.) Burning of any structure should be referred to a forest officer.
- Salvage operations
- Motor vehicles
- Oils
- Rubber
- Plastics
- Chemically-treated materials
- Other materials which produce excessive or noxious smoke, such as, but not limited to: tires, railroad ties, chemically-treated lumber, composite board, sheet rock, wiring, paint, paint filters, mattresses, stuffed furniture
- Garbage, defined as discarded material resulting from the handling, processing, storage, preparation, serving, or consumption of food

### **It is never permissible to burn household garbage.**

## **FIRE DEPARTMENTS**

Maple Lake Fire Department serves all parts of Corinna Township that are east of a north-south line dividing Cedar Lake. Annandale Fire Department serves all parts of Corinna Township west of the north-south line dividing Cedar Lake.

## **DOGS**

Krista Grossinger is the Corinna Township Animal Control Officer. Most of her activities deal with lost or stray animals. If you have a problem with a stray animal, contact Animal Control Officer Krista Grossinger at 320-420-5888. Impounded animals are taken to the Annandale Veterinary Clinic – phone 320-274-3535.

## RECYCLING – NOW SINGLE SORT

The following are recyclable: aluminum beverage cans; metal food cans; glass bottles and jars (all colors); plastic containers and lids (#1-7); cartons – milk, soup, broth, wine, juice boxes; newspaper; cardboard; boxboard (cereal, cracker, shoe boxes); mixed mail (magazines, office paper, envelopes).
