Instead, the thought was that they could take the amount that would be spent on paving and put it into an escrow account that the Township would use later to pave the road instead of assessing the three lot owners in this plat. The estimates they provide for construction costs (of both the road and the storm water improvements) should break out the additional cost related to paying.
