Inventory of Corinna Township road signs damaged by Trump bumper stickers was reviewed. There are 41 damaged signs. The Town Board advised the maintenance men to try to repair 36 signs and replace 5 that had also

After discussion, Town Board told Maintenance Department to take out the "no parking" signs by Lake Center Grill as they are outdated, bent over and faded. Did not want to spend money to replace these; replace "no parking" signs that are illegible on Ireland AVE NW near Schroeder Park; replace "no parking" signs on Ingram and Iresfeld.

Steve Jost asked if the Town Board was considering a new salt shed. There was no conclusion.

Clerk Brown is to find road counts for Gowan AVE NW that have been done within the past few years.
