Approve or Amend Agenda, Town Board Meeting, July 5, 2022: A motion was made by Smith, seconded by Dearing, to approve the Agenda with the following addition: Michael Holmstrom, Jr. would like to address the Town Board. <u>Approve or Amend Minutes, Town Board Meeting, June 21, 2022</u>: A motion was made by Smith, seconded by Dearing, to approve the June 21, 2022 Meeting Minutes. Motion carried unanimously.

Maintenance Outlook Report and Calendar: Reviewed. Central Applicators sprayed all wild parsnip areas and all broadleaf on both sides of 65th, 63rd, and 80th Street. They did not spray Hart Avenue.

Maintenance Dept. plans to start Hart Ave. Project in early August. Midco will move their box to west side of road. Wright Hennepin will go underground. Windstream -1st week of August. Mares will start with Maintenance Dept. 1st week of August.

Goelz said a bigger jetter is not worth the money. It would be best to have a trailer and pull with our water truck instead. There are 3-4 used ones available. 750 gallon tank is a good size. Maintenance Department is checking into used trailer.

<u>8270 Irvine Ave. NW – Water Issue</u>: Steve Grabski is checking his sewer and abstract and will get back to Steve Jost regarding a drywell project on Grabski's property. This will help with road drainage. Corinna Township will do the work at Township's expense.

<u>Dead End or No Turn-Around Sign – Ireland and 117th</u>: Sign was discussed. Clerk Brown will report back regarding sign.

Requests to be on the Agenda:

1. <u>Michael Holmstrom</u>, Jr.: Holmstrom is running for County Commissioner. He said that he is a life-long resident of Wright County. The county is growing fast. Doesn't want communities outside of Buffalo to lose their identities. He wants to protect the Wright County Sheriff's Department. Townships are important to him.
