Request Gravel and Chloride Quote in December for 2023: A motion was made by Smith, seconded by Dearing, to advertise chloride bid, same quantities as 2022, and accept gravel quotes, same quantities as 2022. Motion carried unanimously.

She described Wright County's new Enterprise Resource Project – under which all Wright County finances will be in one program – to increase efficiency and to reduce room for error.
