<u>Approve or Amend Minutes, Town Board Meeting, August 15, 2023</u>: A motion was made by Smith, seconded by Dearing, to approve the August 15, 2023 Town Board Meeting Minutes. Motion carried unanimously.

<u>Maintenance Outlook Report and Calendar</u>: Reviewed. Have Carefree Lawn winterize cemetery in October. Hollister – met on site – maintenance department is widening road at S curve, but not taking out existing tar. Started 9/5/2023. Will fill and do top layer of gravel 9/6.
