Approve or Amend Agenda, Town Board Meeting, Sept. 2, 2025: A motion was made by Smith, seconded by Dearing, to approve the Agenda as presented. Motion carried unanimously.

Approve or Amend Minutes, Town Board Meeting, August 19, 2025: A motion was made by Smith, seconded by Dearing, to approve the August 19, 2025 Town Board Meeting Minutes. Motion carried unanimously.

Maintenance Outlook Report and Calendar: Reviewed.

Ron Bray - Hollister Cement Road Feasibility Report: No discussion. Special Meeting set for Sept 23rd, 2025.

DRN Road – 105th ST NW: Will be moving mailboxes on 105th & Hoyt to 106th have talked with homeowners and post office. Installing new approach for Mol's and adding on to other approaches.

Ireland AVE NW Construction: Discussed asphalt tie in to existing concrete on two driveways. Steve did get a cost and it will be the responsibility of the homeowner to pay.

Bond Financing Information – Ireland and DNR Roads: George Eilertson went over the bond information. Smith asked that they move the closing out to October 30, 2025 and Eilertson indicated that would be fine and he will confirm with the bank. Smith made a motion to approve Resolution #2025-11 Authorizing the Issuance, Sale and Delivery of \$1,057,000 General Obligation Certificate of Indebtedness Series 2025A with a closing date set for October 30, 2025. Dearing seconded the motion. Motion carried unanimously.

Easement 6938 Ingram AVE NW - Staked by Otto and Associates: Dearing indicated that he had talked with the land owner and will be getting confirmation next week if we can move forward.

Sylvester Custom Grinding Proposal: Smith made a motion to approve the grinding of the stumps only. Dearing seconded the motion. Motion carried unanimously.



Payment of Claims:


